ABOUT THE SUMMIT

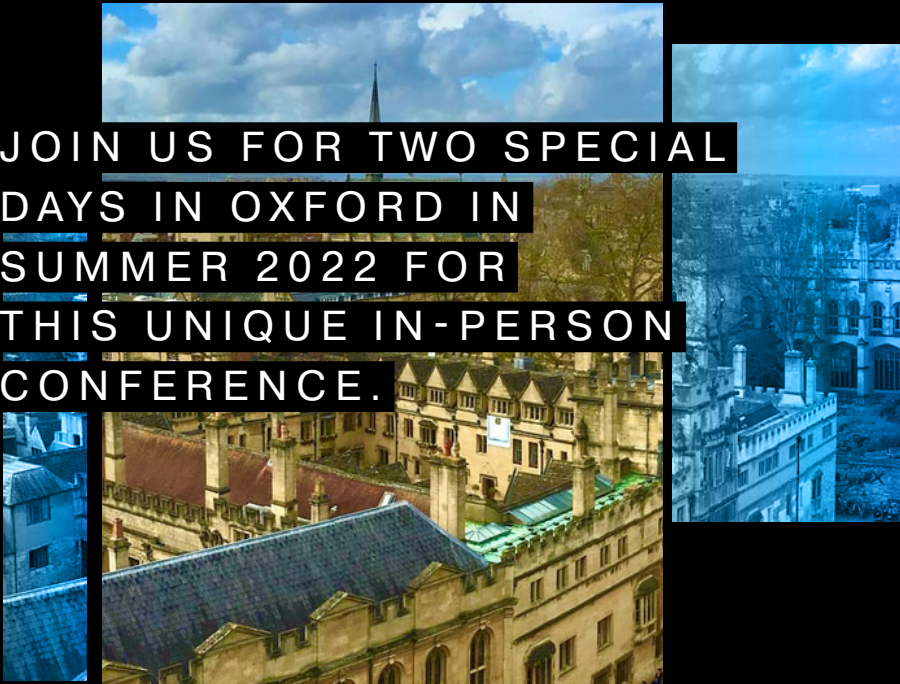

On either side of each summit we also plan to host smaller events together with partners. Do get in touch if you'd like to be involved or if you are interested in supporting future summits as a partner.

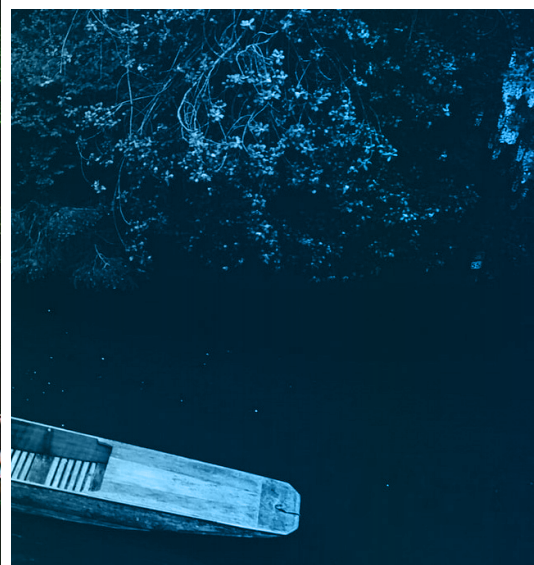

Train

Oxford railway station is approximately a 20 minute walk away or 10 minutes by taxi. Bikes can be hired at the train station or around the city.



Bus

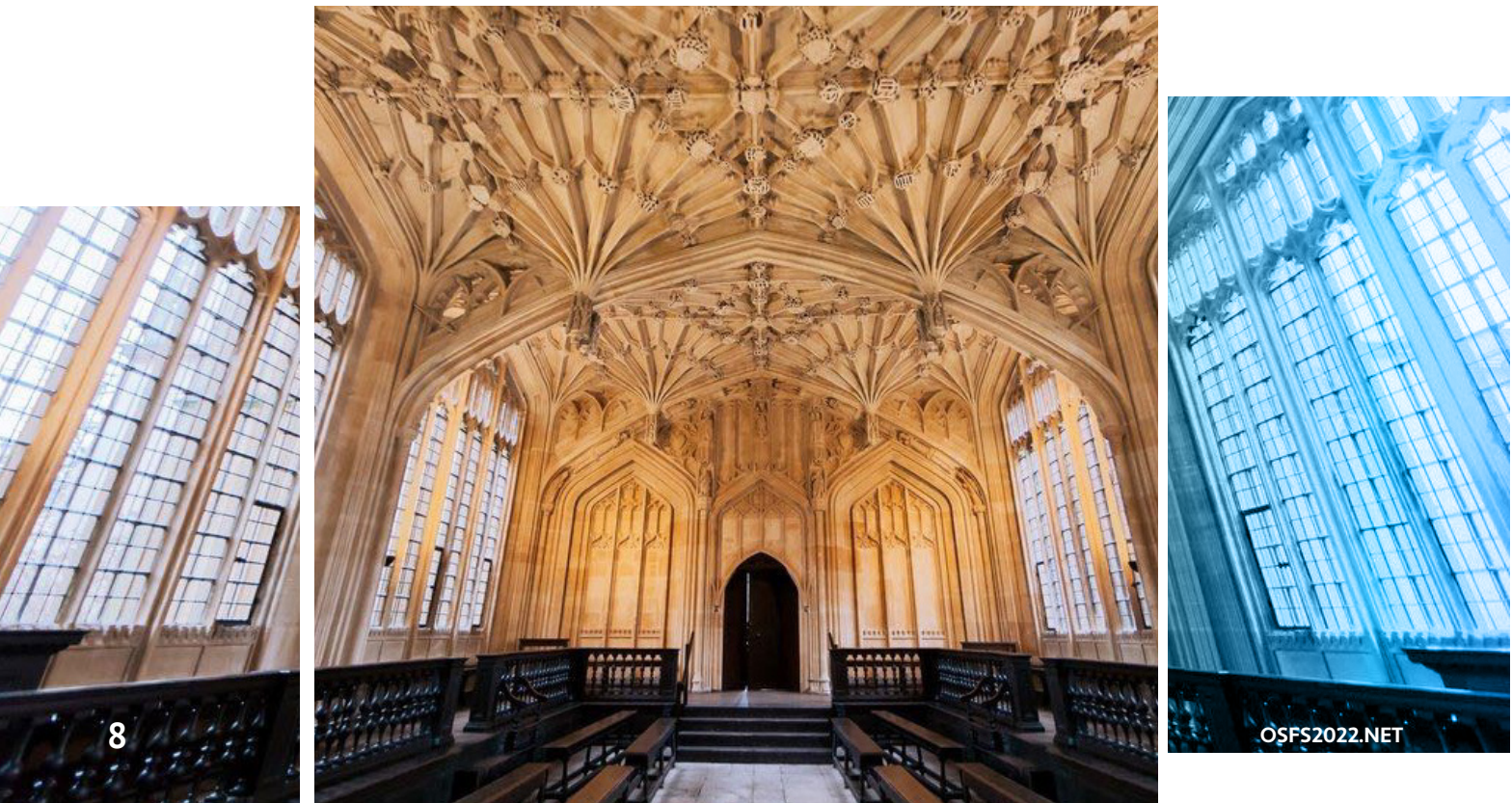

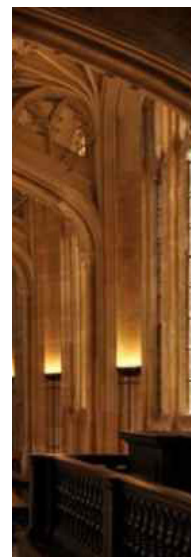
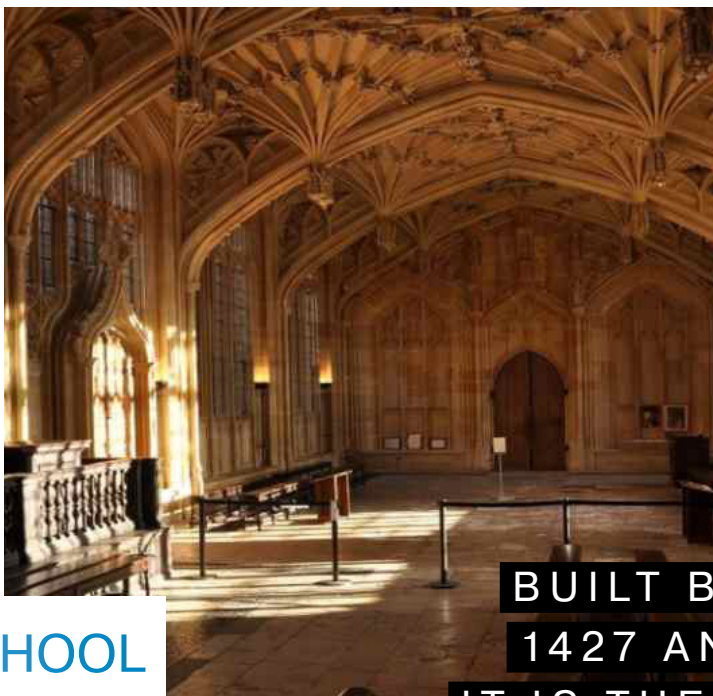

THE EXAMINATION SCHOOL

Main Conference Venue on Wednesday 20th and Thursday 21st July 2022.

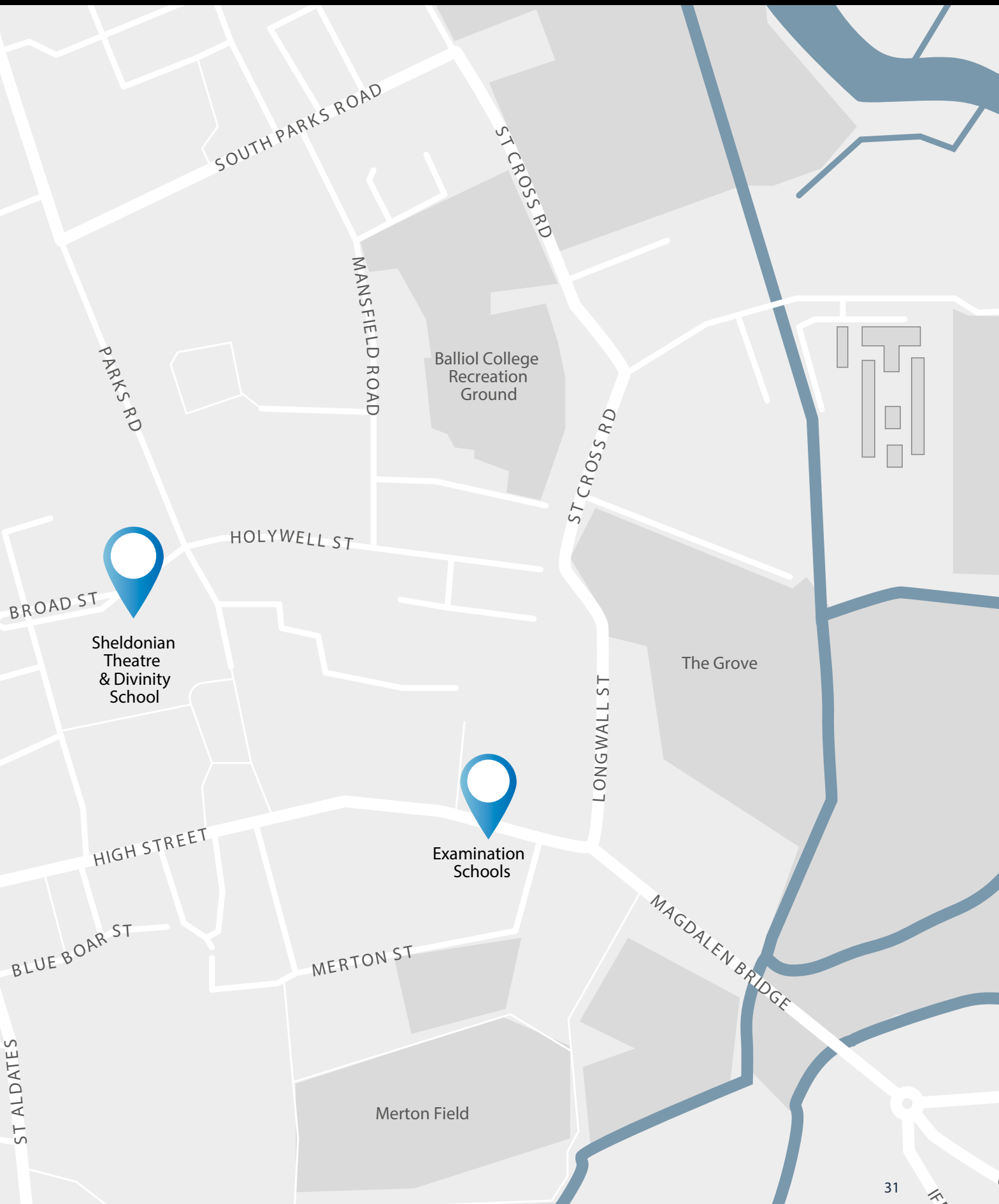

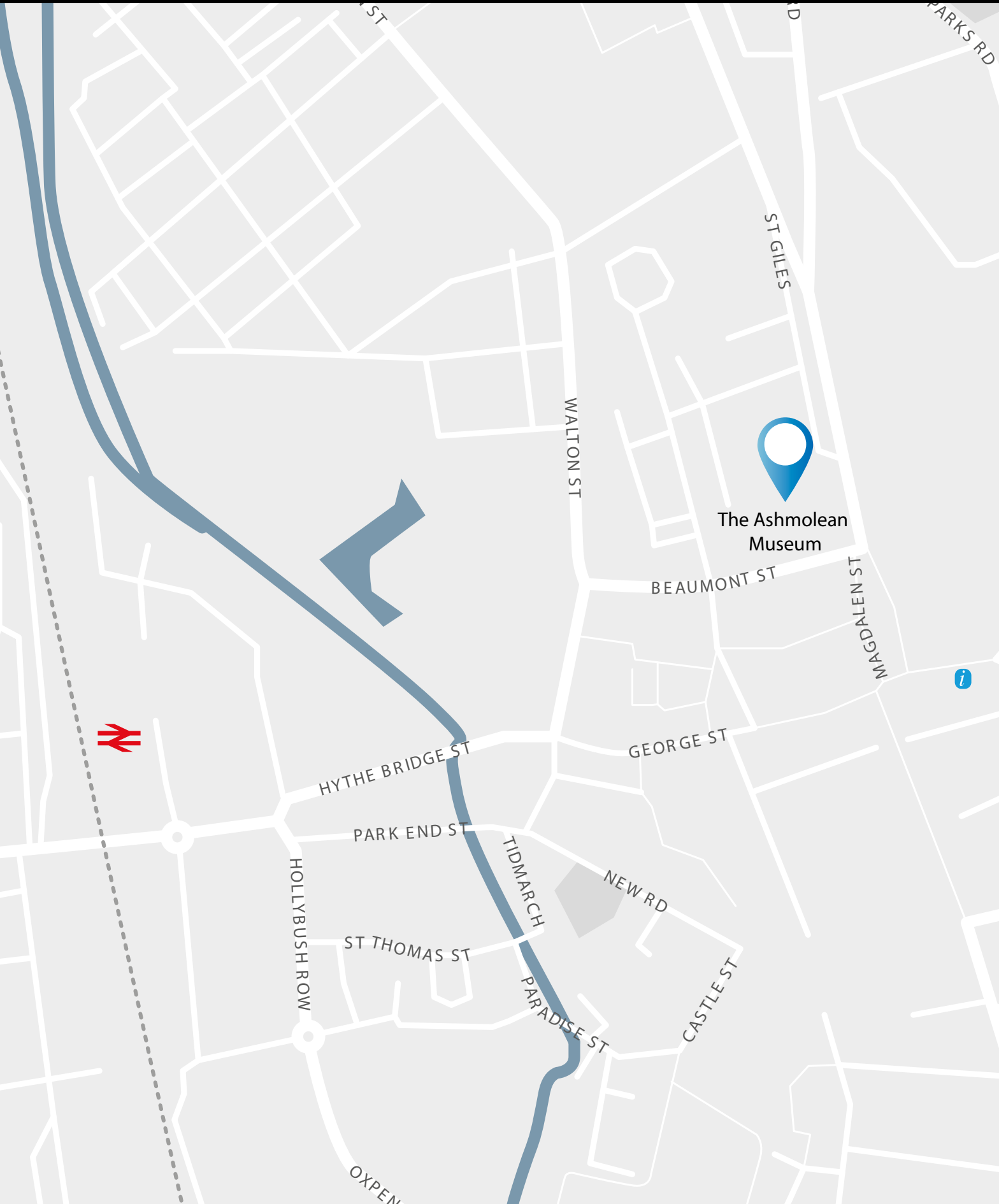

Maher Al-Haffar joined CEMEX in 2000 and has held several executive positions, including Managing Director of Finance, Head of Investor Relations, and most recently, Executive Vice President of Investor Relations, Corporate Communications and Public Affairs. Additionally, he is a member of the NYSE Advisory Board, and before joining CEMEX, he spent nineteen years with Citicorp Securities Inc. and with Santander Investment Securities as an investment banker and capital markets professional. Clara is Senior Partner at Just Climate. Previously, Clara was Chief Executive of the Impact Management Project (IMP) and led the IFRS Foundation's project to establish the International Sustainability Standards Board (ISSB), under the direction of the IFRS Foundation's Trustees.

Clara's public interest work with the IMP was made possible through a secondment from her role as a Partner at Bridges Fund Management, where she led the firm's sustainable and impact strategies across fund types.

Prior to Bridges Fund Management, Clara worked for Acumen's Capital Markets team and later co-led the Acumen renewable energy portfolio, investing in India and East Africa. Clara received a BA (Hons) in Greats from Oxford University, and an MBA from INSEAD.



SARAH BARKER

Partner, Head of Climate & Sustainability Risk Governance, MinterEllison

Sarah Barker leads the climate and sustainability risk governance team at the Asia-Pacific's largest commercial law firm, MinterEllison. She has more than two decades' experience as a corporate lawyer, and is regarded as one of the world's foremost experts on climate change governance, finance and liability risks. In addition to a roster of large ASX-, NYSE- and LSE-listed clients across the banking, financial services, mining, industrial and retail sectors, Sarah's expertise has been called upon by institutions from the Bank of England to UN Principles for Responsible Investment. She brings the practical perspective as an experienced non-executive director in the financial services sector, having recently completed two terms on the board of one of Australia's largest pension funds. Sarah is a non-executive director of the Commonwealth Climate & Law Initiative, sits on the SteerCo of the Australian Chapter of the international Climate Governance Initiative, and on the Australian Accounting Standards Board's Sustainability Reporting Advisory Committee. Sarah led the team recognised as global Law Firm of the Year – Impact by Environmental Finance in 2020.

Rob Bauer is Professor of Finance (chair: Institutional Investors) and holder of the Elverding Chair on Sustainable Business, Culture and Corporate Regulation at Maastricht University School of Business and Economics in The Netherlands.

His academic research is focused on pension funds, strategic investment policy, sustainable finance, responsible investing, shareholder activism and corporate governance.

Rob is also Co-Founder and Director of the European Centre for Sustainable Finance (ECCE) at Maastricht University, Executive Director of the International Centre for Pension Management (ICPM) in Toronto, Co-founder of GRESB (real estate benchmarking company) and Co-Chair of the Global Research Alliance on Sustainable Finance and Investment (GRASFI).



IRENE BENITO

Senior Manager, European Affairs, Planet

Irene Benito is a Senior Manager for European Affairs at Planet. Prior to joining Planet, Irene managed the Copernicus programme at EIT RawMaterials (a body of the EU) and also worked as a policy analyst at the European Commission's Joint Research Centre. Irene has been appointed as an Earth Observation Evangelist at the European Forum for Earth Observation, acting as a spokesperson for the EO sector. She holds a Masters degree in Economics from the London School of Economics (UK).



FARNAM BIDGOLI

Global Head of ESG Solutions, HSBC

Farnam is HSBC's Global Head of ESG Solutions, where she works with HSBC's clients across all sectors on sustainable finance and ESG considerations. Farnam has spent over 10 years in finance and investment banking, and has advised corporations and governments globally on sustainability in the context of corporate strategy, equity capital raisings, and debt issuance. Previously, she led HSBC's EMEA and Americas Sustainable Bonds team, where she was instrumental in building out HSBC's award-winning franchise in green, social, sustainability, and sustainability-linked bonds, including landmark transactions for Repsol, Chanel, FEMSA, and Telefonica, as well as sovereign issuers including the UK, the Netherlands, Canada, Indonesia and Chile. She is HSBC's representative to the ICMA Green Bond Principles Executive Committee, where she co-chairs the Climate Transition Finance Working Group, and sits on the facilitated emissions working group at the Platform on Carbon Accounting Financials as well as the green hydrogen project team at Breakthrough Energy Catalyst. She also sits on HSBC Holdings' Treasury Sustainable Finance Committee.

Prior to joining HSBC, Farnam was with the leading ESG ratings firm Morningstar Sustainalytics, where she developed its second opinion services for labelled bonds, designed the firm's methodology for the assessment of human rights risk in corporate activities, and supported some of the world's largest asset owners as they integrated ESG across asset classes. She is a graduate of the University of Toronto (Hons B.A in International Relations) and University of Oxford (Masters in Business Administration).



DR JULIA ANNA BINGLER

Fellow, Council on Economic Policies

Julia Anna Bingler is a fellow with CEP, where she focuses on integrating climate and environmental risks in financial regulation and monetary policy. Prior to joining CEP, Julia did her PhD in Economics at ETH Zurich, where she focused on climate transition risk metrics and climate risk disclosures, and developed a strong interest in Machine Learning and Natural Language Processing. Before starting the PhD, Julia worked at a think tank in Germany on sustainable finance regulation and the implementation of Art. 2.1c of the Paris Agreement. Julia regularly participates in the UNFCCC climate conferences as an observer on finance-related topics. She holds a M.Sc. in Economics from Leipzig University and in Environmental Economics and Climate Change from London School of Economics and Political Science.

She is a former Senior Partner at McKinsey & Company focused on financial institutions, capital markets, and risk management in Europe and the United States.

She served at the Bank of England as an external member of the Prudential Risk Committee and the senior independent member and risk committee chair of the Board that oversees the system used to make high-value payments and implement monetary policy. Sandy also has served as non-executive director at two public companies: Elementis Global and Enstar Group.

In 1995, he was appointed as Chairman of the Management Board of the then created international partnership and became in 2012 Chairman of the Supervisory Board. Since late 2014, he has been Honorary President of the Mazars Group.

SASKIA DE VRIES

Head of the International Financial Architecture, De Nederlandsche Bank

Saskia de Vries is currently Head of the International Financial Architecture department at the Financial Stability division of De Nederlandsche Bank. She is also Co-chair of the NGFS Task Force on Nature-related Risks. He is the Founding Chairman of the Sustainability Accounting Standards Board (SASB) and one of the founders of the International Integrated Reporting Council (IIRC). He has recently joined the board of Mistra Centre for Sustainable Markets (MISUM) in Sweden. Bob is also on the Advisory Board of the JANA Impact Capital Fund.

In 2011, Bob was selected as one of the Top 100 Thought Leaders in Trustworthy Business Behavior, for his extensive, positive contribution to building trust in business, and in 2014 and 2015 he was named as one of the 100 Most Influential People in Business Ethics. He is also an Honorary Fellow of the Association of Chartered Certified Accountants (ACCA).

Bob is the award-winning author of a dozen books, including seminal works on integrated reporting, sustainability, and the role of business in society. A prolific writer for both academic and practitioner audiences, he has his own column on Forbes.com. His most recent book (with Michael P Krzus and Sydney Ribot) is *The Integrated Reporting Movement: Meaning, Momentum, Motives, and Materiality* (John Wiley & Sons, 2015). In this book he suggests the idea of an annual board of directors 'Statement of Significant Audiences and Materiality'.

From the beginning of his career as an academic and practitioner, Bob has always been



dedicated to turning theory into practice. One of his most significant current efforts in this regard is 'The Statement of Significant Audiences and Materiality Campaign' in collaboration with the American Bar Association's 'Task Force on Sustainable Development', the UN-backed Principles for Responsible Investment, and the UN Global Compact. The goal of this campaign is that, by 2025, the board of directors of every listed company will publish 'The Statement.' In doing so, they will demonstrate the extent to which the company views its role in society to be one of supporting sustainable development for the long-term interests of shareholders. This will help to make sustainability core to both companies and investors.

Bob received an SB in Mathematics and an SB in Humanities and Science from the Massachusetts Institute of Technology (both degrees in 1973) and an AM (1975) and a PhD in Sociology (1979) from Harvard University. He joined the faculty of Harvard Business School that year and received tenure in 1989.

DR ULF ERLANDSSON

CEO, Anthropocene Fixed Income Institute



Dr Ulf Erlandsson is the CEO and founder of the Anthropocene Fixed Income Institute (AFII), a research institute and advocacy focusing on fixed income markets and the climate transition. Launched in 2020 and backed by prominent climate philanthropies, AFII's work is based on the team's practical experience from fixed income market. Dr Erlandsson was previously running global credit, SSAs and a total return strategy at Swedish state pension fund AP4. Former Canadian Minister of Environment & Climate Change and Chair, UN High-Level Expert Group on the Net-Zero Emissions Commitments of Non- State Entities

Catherine McKenna is the founder and principal of Climate and Nature Solutions. She is Chair of the UN Secretary-General’s new High-Level Expert Group on Net-Zero Commitments of Non-State Entities (companies, investors, cities and regions) and is a Distinguished Visiting Fellow at Columbia University’s Climate School and launched “Women Leading on Climate” at COP26.

Catherine was Canada's Minister of Environment and Climate Change in Prime Minister Justin Trudeau's government where she was asked by France to facilitate the negotiations of Article 6 of the Paris Agreement (the market text) at COP 21. She led negotiations of Canada's first national climate plan which included a price on pollution across the country. In this role she helped establish a number of global initiatives including the Powering Past Coal Coalition, the Ministerial on Climate Action and the Nature Champions Summit.

Later, as Minister of Infrastructure and Communities she made historic investments in public transit and green and resilient infrastructure, leveraged private sector investment to get more public infrastructure built through the Canada Infrastructure Bank, and led the development of Canada's first National Infrastructure Assessment to drive Canada to net-zero emissions by 2050.

Before politics, Catherine practiced trade law in Canada and Indonesia, worked as a legal advisor for the United Nations Transitional Authority in East Timor, and co-founded Canadian Lawyers Abroad. She is a mother to three and spends her free time swimming.

Professor of Climate Finance, EDHEC Business School

Irene Monasterolo is Professor of Climate Finance at EDHEC Business School and EDHEC-Risk Institute in Nice (FR). Irene's research is contributing to understand the role of finance in the low-carbon transition, and the implications of climate change on investment decisions and financial stability. In the context of climate-related financial risks, Irene has co-developed the Climate Policy Relevant Sectors (CPRS), a science-based classification of assets into classes of climate transition risk, and the climate stress-test of the financial system, which embeds climate scenarios in asset pricing, financial risk metrics and portfolio risk assessment.

Irene's research is currently focusing on the development of (i) asset-level approaches to dynamic climate financial valuation, applied to the analysis of cascading climate risks; (ii) enhanced scenarios and dynamic balance sheet models for climate stress testing; (iii) analysis of tail risk of climate change in financial risk metrics (iv) enhanced greenness measures to inform portfolio rebalancing strategies. Irene's research has been published in top and high-ranked journals in the field, including Science, Nature Climate Change, and Journal of Banking and Finance, as well as Brookings and UN PRI.
